Rhode Survey No. 96, Abstract No. 1327 and out of the Gabriel Arreola Survey No. 38, Abstract 5, Medina County, Texas, being a portion of an 83.347 acre tract as conveyed to Earl Holdings, LLC as recorded in Document No. 2014031164, and a portion of an 83.271 acre tract as conveyed to Hasuman Holdings, LTD. as recorded in Document No. 2014031167, both of the Official Public Records, Medina County, Texas.
