WHEREAS, the Commissioners Court (the Court) of Medina County, Texas (the County), has received a petition (the TIRZ Petition), which petition the Court has determined to be validly submitted and compliant with applicable laws of the State of Texas (the State), concerning the creation of a tax increment reinvestment zone (the TIRZ), to be named Reinvestment Zone Number Two, Medina County, Texas, across property located within the County and as further described in the TIRZ Petition, as required and in compliance with Chapter 311, as amended, Texas Tax Code (the TIRZ Act); and

WHEREAS, the Court has received a petition (the PID Petition), which petition the Court has determined to be validly submitted and compliant with applicable laws of the State, concerning the creation of a public improvement district (the PID), to be named Potranco Ranch Public Improvement District, across property located within the County and as further described in the PID Petition, as required and in compliance with Subchapter A of Chapter 372, as amended, Texas Local Government Code (the PID Act and, together with the TIRZ Act, the Acts); and

WHEREAS, pursuant to each of the Acts, prior to the action of the Court concerning the creation of a TIRZ or a PID, the Court is required to conduct a public hearing concerning any such creation and publish notice thereof in a newspaper of general circulation in the County, each of which notices shall contain, at a minimum, the requisite information specified in the applicable provisions of the Acts; and

WHEREAS, the Court hereby finds and determines that, based on its receipt of the TIRZ Petition and the PID Petition, the County should proceed with the conduct of separate public hearings concerning the creation of each of the TIRZ and the PID and the giving of notice of such public hearings in the time, form, and manner provided by law; and

WHEREAS, the Court hereby finds and determines that these actions are in the best interests of the residents of the County; now, therefore

SECTION 1: The County Clerk is hereby authorized and directed to cause notice to be published of the Court's intention to conduct a public hearing concerning the creation of the TIRZ. The TIRZ creation public hearing notice hereby approved and authorized to be published shall read substantially in the form and content of Exhibit A attached hereto, which notice is incorporated herein by reference as a part of this Resolution for all purposes.

SECTION 2. The County Clerk is hereby authorized and directed to cause notice to be published of the Court's intention to conduct a public hearing concerning the creation of the PID. The PID creation public hearing notice hereby approved and authorized to be published shall read substantially in the form and content of Exhibit B attached hereto, which notice is incorporated herein by reference as a part of this Resolution for all purposes.

SECTION 3: The County Clerk shall cause the aforesaid notices to be published in a newspaper of general circulation in the County, (i) with respect to the notice concerning the creation of the TIRZ, at least seven days before the scheduled date of the public hearing and (ii) with respect to the notice concerning the creation of the PID, at least fifteen days before the scheduled date of the public hearing. In addition, the County Clerk is hereby authorized to mail notices of the creation of the PID as required (and as provided) under Section 372.009(d), as amended, Texas Local Government Code.

SECTION 4: The recitals contained in the preamble hereof are hereby found to be true, and such recitals are hereby made a part of this Resolution for all purposes and are adopted as a part of the judgment and findings of the Court.

SECTION 5: All orders and resolutions, or parts thereof, which are in conflict or inconsistent with any provision of this Resolution are hereby repealed to the extent of such conflict, and the provisions of this Resolution shall be and remain controlling as to the matters resolved herein.

SECTION 6: This Resolution shall be construed and enforced in accordance with the laws of the State of Texas and the United States of America.

SECTION 7: If any provision of this Resolution or the application thereof to any person or circumstance shall be held to be invalid, the remainder of this Resolution and the application of such provision to other persons and circumstances shall nevertheless be valid, and this Commissioners Court hereby declares that this Resolution would have been enacted without such invalid provision.

NOTICE OF PUBLIC HEARING

A public hearing will be conducted by the Commissioners Court of the County of Medina (the "County") on the <a href="https://dayofc.new.nih.gov/pt.new.new.nih.gov/pt.new.nih.gov/pt.new.nih.gov/pt.new.nih.gov/pt.new.n

The name of the proposed district will be "Potranco Ranch Public Improvement District" (the "District"). The District will be created and organized under the terms and provisions of Article III, Section 52; and Article III, Section 52-a, Texas Constitution and the inherent power of the Texas Legislature to authorize the creation of special districts of the State and to promote economic development.

The District will contain an area of approximately 320 acres of land, situated in Medina County, Texas. All of the land proposed to be included within the District may properly be included within the District. The boundaries of the proposed District are located on the south side of Potranco Road (FM 1957), approximately 2,500 yards west of County Road 381 and more particularly described in Exhibit "A", attached hereto and incorporated herein for all purposes.

The owners of fee simple title to more than 50 percent of the appraised value of the taxable real property proposed to be included within the proposed District have requested and consented to the creation of the District.

This Petition requests that the County create a public improvement district and authorize it to engage in economic development projects and grant to the District the powers requested in the Petition. The District proposes to enter into development agreements as are deemed advisable to promote state and local economic development and to stimulate in the District, and to build and fund projects for the benefit of the District and the County.

The general nature of the work proposed to be done within the boundaries of the proposed District includes, but is not limited to, inducements and incentives for the development and construction of high quality, sustainable, and environmentally sound Residential Development of a gated, "large" lot subdivision and fund and construct improvements to Potranco Road, install and maintain sewer and water reuse projects, install and maintain roads, drainage, open space, entryways and other improvements within and for the benefit of the District and the County.

The proposed work will be accomplished by entering into agreements to grant or loan County funds collected from assessments imposed within the District; improvements to drainage, water, sewer and recycled water utilities; establishment of roads, associated drainage and trails; land clearing; lighting improvements; construction of entry way features; signage; and other improvements within the District; and assistance in expansion of police, fire and emergency protection facilities; private security services; establishment of conservation easements, including the costs of acquisition of open space, and payment of costs of management of the areas so encumbered or acquired; payment of costs of compliance with any environmental permits issued for lands within the District. The District will comply with Chapter 372, and specifically Subchapter A thereof, in determining its undertakings.

The area within the proposed District is capable of attracting premium, sustainable, and environmentally sensitive single family housing in the District and the County. The proposed District is necessary in order to finance economic development projects and improvements within the District which will promote and develop new and expanded master planned residential development projects and increased ad valorem tax base of approximately \$126,000,000 (based on current estimates). The proposed District and its projects appear to be a benefit to the land within and the economy of the District and the County. The proposed District will serve the public purpose of attracting desired and beneficial development to the District and the County and stimulating economic development and job creation within the District and the County. The capital cost of the projects proposed to be pursued within the District and the area of the County that surrounds the District as currently contemplated are estimated by the Petitioner to be \$25,530,000. The ongoing costs of maintenance of the residential subdivision's sewer and recyclable water will be funded, in part, by the annual assessments of the District. Open space, common areas and agricultural exempt property will be exempt from the assessment; and assessments will be made only on the taxable value of tracts or lots after homes have been constructed on the same and sold from the builder to the private owner, and then thereafter.

The County shall not be requested to pay for any of the costs of the District from the County's current tax base. The only contribution of tax revenue contributed to the District will be in the form of payments from the Reinvestment Zone Number Two, Medina County, Texas, when and If created, from the new tax increment generated within the boundaries of the District

The County is requested at the close of the public hearing, should it adopt an Order creating the District, to appoint five individuals who are qualified under Chapter 372, Local Government Code, to serve as the Board of Directors of the District.


